## EffecTech Gas Quality Engineer Responsibilities

#### Main responsibilities

- undertaking inspections and instrument validations/calibration on gas chromatographs or other instrumentation including
  - performance evaluations in accordance with the international standard ISO 10723:2012
  - o inspections of gas quality measurement systems
- producing and peer-reviewing inspection reports, calibration reports and calibration certificates
- discussing work with clients as necessary
- record keeping
- Planning and scheduling site work, including liaising with clients and booking hotels and travel, in conjunction with the Senior Engineer
- preparation of necessary supplies, such as reference gases, to complete work on-site
- Arranging the transport for these supplies to and from site through liaison with the logistics department
- maintaining site method statements and preparing risk assessments and HSE statements in order to obtain individual site permit to work and adhering to the client's site procedures

## General responsibilities

- assisting the Senior Gas Quality Engineers in their day-to-day duties when required
- assisting the Quality Manager with the continual development and improvement of the quality system
- assisting the Health and Safety Manager in the development of environment, health and safety procedures including ADR/CDG transport regulations, cylinder storage & movement associated with the site services department
- carrying out general administration, including booking company van services and MOTs and maintaining training records
